We further agree that no change or addition to or other modification of the terms of the contract to be performed there under or of any of the contract documents which may be made between you and the Bidder shall in any way release us from any liability under this guarantee and we hereby waive notice of any such change, addition or modification.

Notwithstanding anything contained herein:

Instruction to Transporters for preparation of Performance Bank Guarantee (PBG)

1. As you are aware, PBG of Rs. 50,000/- is required for each vehicle applied to be empanelled for transportation of liquor and related items in Excise Department, Government of Bihar.
2. If a transporter have applied for more than one vehicle, then

PBG amount = Rs. 50,000/- X Nos. of vehicles applied

Example (i), if applied for 20 vehicles

PBG amount = Rs. 50,000/- X 20
= Rs. 10,00,000/-

Then a PBG of Rs. 10,00,000/- needs to be made and submitted. However, if a transporter wants to submit multiple PBGs against 20 vehicles, then he can split the nos. of vehicles according to the amount and submit the details of vehicles accordingly.

For example, 20 vehicles may be split in

(a) 10 vehicles, (b) 6 vehicles and (c) 4 Vehicles.

and submit 3 PBGs in denomination of

(a) Rs. 5,00,000/-, (b) Rs. 3,00,000/- and (c) Rs. 2,00,000/-.
