26.	Do we have to register Containers/Tankers for inbound/outbound consignment for transportation of liquor and related products into/from State of Bihar.	Yes.
27.	Is 29 <sup>th</sup> February 2016 the last day for submission of application for registration of tankers/containers?	Yes for 1 <sup>st</sup> Phase. However, based on the status of the demand and supply of vehicles, the registration may be allowed even after the due date till the demand is met.
28.	After unloading at the unit(s) in Bihar, would the vehicle be allowed to undertake transportation of any other material which is not part of liquor or related items from any other location in the State?	Prior intimation to Excise Department.
29.	For inbound transportation, it would be difficult to register a fixed number of vehicles. Would be it possible that transporters pay advance PBG for certain number of vehicles and as per requirement, intimate the Excise Department?	Yes.
